Wednesday, September 1, 2021.—The members of the Board of Regents of the Texas Tech University System convened in a special-called meeting at 9:02 am on Wednesday, September 1, 2021, in the Comanche Suites (Room 135), Clark Student Center, Midwestern State University, 3410 Taft Boulevard, Wichita Falls, Texas, with the following in attendance:

- I. MEETING OF THE BOARD—CALL TO ORDER; CONVENE INTO OPEN SESSION OF THE BOARD.—At 9:02 am, Chairman Lewis announced a quorum present and called the meeting to order.
 - A. OPENING REMARKS AND RECOGNITIONS.—The Board continued in Open Session. A welcoming video was shown after which Chairman

Lewis and Chancellor Mitchell welcomed Midwestern State University (“MSU”) as a member of the Texas Tech University System.

Special recognition was given to Dr. Suzanne Shipley, Midwestern State University’s Former President, for her long and dedicated service to MSU.

B. COMMITTEE OF THE WHOLE.—Chairman Lewis facilitated action on the items to be considered by the Committee of the Whole.

I.B.1. TTUS: Authorize resolution honoring the former Board of Regents and Administration of Midwestern State University and marking Midwestern State University’s addition to the Texas Tech University System.—The Board issued the resolution as listed below in honor of the Midwestern State University Board of Regents and university leadership and in recognition and appreciation of their collaborative spirit in securing the addition of Midwestern State University as the fifth member institution of the Texas Tech University System, effective September 1, 2021, as authorized by House Bill 1522 of the 87th Texas Legislature.

Texas Tech University System Board of Regents

RESOLUTION OF THE BOARD

WHEREAS, The Board of Regents of the Texas Tech University System celebrates the collaborative strategic partnership with the Midwestern State University (Wichita Falls, Texas) Board of Regents and university leadership, and is proud to welcome Midwestern State University as the fifth member institution of the system; and

WHEREAS, The State of Texas has transferred Midwestern State University to the Texas Tech University System, effective September 1, 2021, following the authorization of House Bill 1522, which was signed into law by Governor Greg Abbott on Tuesday, June 8, 2021; and

WHEREAS, House Bill 1522, authored by State Representative James Frank and sponsored by State Senator Drew Springer during the 87th Texas Legislature, was passed by the Texas House of Representatives on April 14, 2021, passed by the Texas Senate on May 21, 2021, and signed by the Governor on June 8, 2021; and

WHEREAS, *Midwestern State University*, approaching its centennial anniversary, has an established, longstanding reputation in higher education as a liberal arts leader in Texas and as a provider of outstanding, transformational educational experiences for its students; and

WHEREAS, *Midwestern State University* fosters a close-knit, values-based culture that aligns well with the component universities and System Administration of the Texas Tech University System; and

WHEREAS, *Midwestern State University* will bring significant value to the Texas Tech University System and its institutions as it furthers the system’s collective mission of educating future generations and advancing higher education, health care, research and leadership in our communities; now, therefore, be it

RESOLVED, That the Board of Regents of the Texas Tech University System on this date, September 1, 2021, do hereby extend its heartfelt appreciation to the *Midwestern State University* Board of Regents, administration, students, faculty, staff, alumni and friends for the vision and commitment to the betterment of higher education in Texas; and, be it further

RESOLVED, That copies of this Resolution be prepared for *Midwestern State University* Board of Regents Chairman R. Caven Crosnoe and President Suzanne Shipley, Ph.D., to share as an expression of high regard from the Texas Tech University System Board of Regents for their unwavering dedication to this successful partnership.

- I.B.2. TTUS: Approve amendments to *Missions, Regents’ Rules*, to add a mission statement for *Midwestern State University* (“MSU”) and authorize the chancellor or his designee to make necessary updates to the *Regents’ Rules* incorporating MSU as an institution governed by the Board of Regents of the Texas Tech University System.—The Board approved to: 1) amend the *Missions* chapter of the *Regents’ Rules* to add a mission statement for *Midwestern State University* (“MSU”) and update the mission statement of the Texas Tech University System (“TTUS”) to include MSU; and 2) authorize Chancellor Mitchell or his designee to make the necessary updates to the *Regents’ Rules* incorporating MSU as an institution under the power and authority of the Board of Regents of the Texas Tech University System.

It was proposed that the *Missions* chapter of the *Regents’ Rules* is amended to include the mission statement for MSU to reflect its official designation as the fifth member institution of the Texas Tech

University System, effective September 1, 2021, as authorized by House Bill 1522 of the 87th Legislature. Additionally, the TTUS mission statement will be adjusted to include MSU as a component institution.

Furthermore, Chancellor Mitchell or his designee was authorized to make the necessary administrative updates to various chapters of the *Regents' Rules to reflect the incorporation of MSU* as an institution under the power and authority of the Board of Regents of the Texas Tech University System. An example of a necessary update is the inclusion of language in Chapter 1 (Bylaws) to reflect Section 109.201, Texas Education Code which state that MSU is “under the management and control of the Board of Regents of the Texas Tech University System. The Board of Regents has the same powers and duties concerning Midwestern State University as are conferred on the board by statute concerning Texas Tech University.”

The revised mission statements will read:

Texas Tech University System. The mission of the Texas Tech University System is to provide leadership and support services for Texas Tech University, the Texas Tech University Health Sciences Center, the Texas Tech University Health Sciences Center at El Paso, Angelo State University, and Midwestern State University in the attainment of each component's individual mission.

Midwestern State University (*new addition*). Midwestern State University is a leading public liberal arts university committed to providing students with rigorous undergraduate and graduate education in the liberal arts and the professions. Through an emphasis upon teaching, augmented by the opportunity for students to engage in research and creative activities alongside faculty and to participate in co-curricular and service programs, Midwestern State prepares its graduates to embark upon their careers or pursue advanced study. The university's undergraduate education is based upon a comprehensive arts and sciences core curriculum. The understanding that students gain of themselves, others, and the social and natural world prepares them to contribute constructively to society through their work and through their private lives.

- I.B.3. TTUS: Ratification of existing Midwestern State University (“MSU”) contracts that require approval of the Board of Regents.—The Board approved ratification of all existing Midwestern State University contracts, written obligations including bonds, approval of the MSU FY 22 Budget including tuition and fees effective fall 2021, and all previously approved faculty tenure, which has been duly authorized and previously executed under the governance and

authority of the previous Board of Regents of Midwestern State University (“MSU”) prior to September 1, 2021.

Effective September 1, 2021, as authorized by House Bill 1522 of the 87th Legislature, Midwestern State University will become the fifth component institution of the Texas Tech University System.

House Bill 1522 of the 87th Legislature, Section 4 through Section 7, stipulates that all contracts and written obligations of every kind and character entered into by the board of regents of Midwestern State University, including bonds; approved tuition and fees; the transfer of governance does not effect the employment status or benefits of MSU employees; the transfer of governance does not effect the status of any MSU student; and current funds of MSU are maintained for use and benefit of MSU, are considered ratified, confirmed, and validated by the board of regents of the Texas Tech University System on the effective date of the transfer.

To comply with legislation passed regarding the transfer and The Rules and Regulations of the Board of Regents of the Texas Tech University System, the Board of Regents of the Texas Tech University System, approve, acknowledge and ratify all existing contracts and written obligations duly authorized and previously executed under the governance and authority of the Board of Regents of MSU prior to September 1, 2021.

- I.B.4. TTUS: Ratification of existing Midwestern State University (“MSU”) Operating Policies and Procedures and delegation of authority to MSU’s President to enact or revise MSU Operating Policies and Procedures in the future that do not require TTUS Board of Regents approval.—The Board 1) ratified all existing Midwestern State University (“MSU”) Operating Policies and Procedures; and 2) delegated authority to MSU’s President to enact or revise MSU Operating Policies and Procedures in the future that do not require Texas Tech University System (“TTUS”) Board of Regents approval.

Under existing practice, all MSU university policies and procedures are initiated at the university level and become effective only upon approval by the former Board of Regents as part of the Midwestern State University Policies and Procedures Manual. By contrast, within TTUS, each component university implements and manages operating policies and procedures for its respective institution and campus communities with only certain specified policies and

procedures requiring approval from the Board of Regents. For example, tenure and promotion policies must receive the approval of the board.

The proposal ratifies all existing MSU Operating Policies and Procedures while also authorizing MSU's President to enact or revise MSU Operating Policies and Procedures in the future that do not require TTUS Board of Regents approval.

It should be noted that MSU will be subject to current TTUS *Regents' Rules* and System Regulations the same as other component institutions within the TTU System.

- I.B.5. TTUS: Ratification of the appointment of Dr. James Johnston as Interim President of Midwestern State University.—The Board ratified the appointment of Dr. James Johnston as Interim President of Midwestern State University ("MSU"), effective September 1, 2021.

At the August 5, 2021 meeting of the Board of Regents of Midwestern State University, the former MSU board approved the appointment of Dr. James Johnston as Interim President of MSU, effective September 1, 2021, with a monthly stipend for his service. The former MSU board also approved signature authorization for university bank accounts investment instruments, and appropriate retirement documents for the interim president.

Dr. Johnston began his tenure at MSU in 2003 as an associate professor of radiologic science. He became a full professor with tenure in 2014 and has previously served as the director of interdisciplinary education in the Robert D. and Carol Gunn College of Health Sciences and Human Services.

In August 2012, he was appointed as interim dean of the Gunn College of Health Sciences and Human Services, where he served until being appointed as the college's permanent Dean in February 2013. Dr. Johnston served as the university's Interim Provost from February 2017 until his official appointment as Provost and Vice President of Academic Affairs at MSU in April 2017.

He earned his associate's degree in radiologic sciences from South Plains College, bachelor's degree in radiologic sciences from MSU in 1993, master's in radiologic science from MSU in 2003 and his doctorate in health studies from Texas Woman's University in 2006.

- I.B.6. MSU: University History and Overview Presentation.—The Board accepted a report on the history of MSU and an overview of key programs and operations, included

herewith as Attachment No. 2 (MSU University Overview PowerPoint).

- II. EXECUTIVE SESSION.— At 10:25 am, the Board recessed and convened into Executive Session as authorized by Sections 551.071, 551.072, 551.073, 551.074 and 551.076 of the *Texas Government Code* in the Cheyene Room (Room 171), Clark Student Center, 3410 Taft Boulevard, Wichita Falls, Texas.
- III. OPEN SESSION.—At 11:14 am, the Board continued in open session in the Comanche Suites (Room 135), Clark Student Center, Midwestern State University, 3410 Taft Boulevard, to consider items as a Committee of the Whole and Meeting of the Board.
 - III.A. REPORT OF EXECUTIVE SESSION.—Chairman Lewis called on Vice Chairman Griffin to present motions regarding items discussed in Executive Session.

Vice Chairman Griffin announced there were two motions resulting from Executive Session.

- III.A.1. Vice Chairman Griffin moved that the Board delegate to Chancellor Mitchell the authority to appoint, set the charge to, and determine the process to be used by a Presidential Search Committee in the search for a new president of Midwestern State University ... in accordance with the *Regents' Rules* and under the terms and conditions set forth in Executive Session. The motion was seconded by Regent Campbell and unanimously approved by the Board.
- III.A.2. Vice Chairman Griffin moved that the Board delegate to Chancellor Mitchell or his designee the authority to proceed with the initial steps necessary to establish a tax-exempt 501(c)(3) organization at the Texas Tech University System ... in accordance with the terms and conditions set forth in Executive Session. The motion was seconded by Regent Steinmetz and unanimously approved by the Board.

No action was taken on any other matters that were posted for discussion in Executive Session, which included:

Consultation with Attorney Regarding Legal Matters or Pending and/or Contemplated Litigation or Settlement Offers (Tex. Govt. Code § 551.071) including: Pre-litigation and litigation update; Discussion of potential creation of a 501(c)(3) entity; and Other pending legal matters, potential legal claims updates, settlement offer updates, and discussion and advice from general counsel on pending legal issues.

Deliberation Regarding the Purchase, Exchange, Lease, Sale, or Value of Real Property (Tex. Govt. Code § 551.072).

Deliberation Regarding Prospective Gifts or Donations (Tex. Govt. Code § 551.073).

Deliberation Regarding Individual Personnel Matters Relating to the Appointment, Employment, Evaluation, Reassignment, Duties, Discipline, or Dismissal of Officers or Employees of the TTU System and its Component Institutions. (Tex. Govt. Code § 551.074) including: Discussion of Chancellor duties, assignments, and expectations; and Discussion of other personnel matters including the duties, performance and evaluation of Texas Tech University System or component institution officers and employees.

Deliberation Regarding Security Devices or Security Audits. (Section 551.076).

- III.B. CHAIRMAN'S ANNOUNCEMENTS.—Chairman Lewis made some closing remarks after which a video from Governor Greg Abbott congratulating Midwestern State University on their joining the Texas Tech University System was presented.

MSU Moody's Rating Upgrade Announcement



On August 19th 2021, Moody's Rating Services places MSU A1 ratings under review for upgrade ahead of September 1st, 2021.

"The planned change in organizational structure, with MSU joining TTUS, is a key governance consideration under Moody's ESG framework. Assuming completion of the MSU transfer to TTUS, Moody's expects that the rating on the MSU bonds will be placed relative to TTUS' Aa1 issuer rating consistent with Moody's higher education methodology issuer-level and instrument-level considerations."

MSU Moody's Rating Upgrade Announcement



On September 1st, 2021 Moody's Ratings Services upgrades MSU 2 notches to Aa2.

With the upgrade, MSU's current bondholders may realize a strengthened bond portfolio by MSU joining the Texas Tech University System with repayment expectations morally bound by the University System.

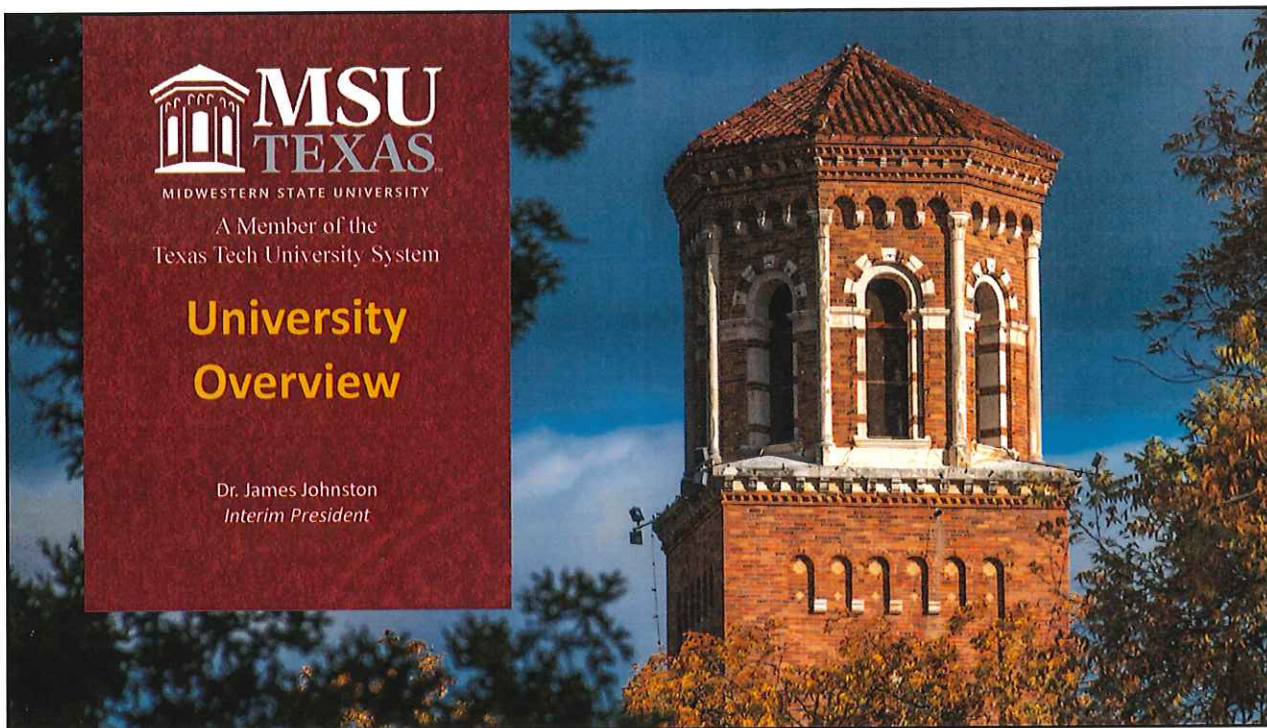

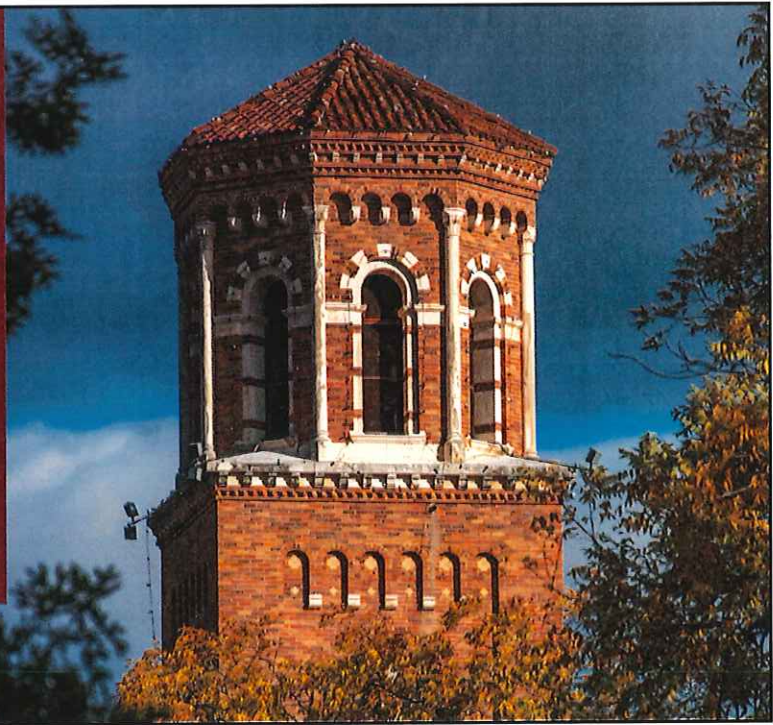

Impact of the 87th Legislative Session

FY 2020 and FY 2021 – Reduction of \$1.55M

All General Academic Institutions were required 5% reduction in general revenue (both formula and non-formula support) in FY 20 and FY 21 – MSU \$1.55M

FY 2022 and FY 2023 Legislative Biennial Impact – Reductions of \$1.2M over 2 years

MSU was required to decrease non-formula funded items by 5% –MSU \$0.2M

MSU formula funding decreased by \$1.0M

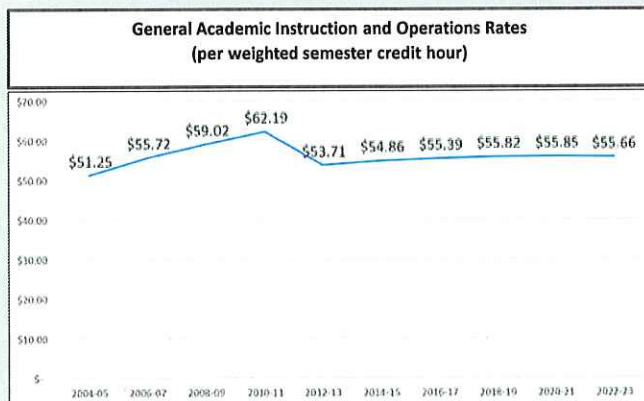
Legislature added \$380M to fund enrollment growth and other formula items for all higher ed
 – MSU \$1.75M over 2 years

No additional appropriation was received to fund inflation

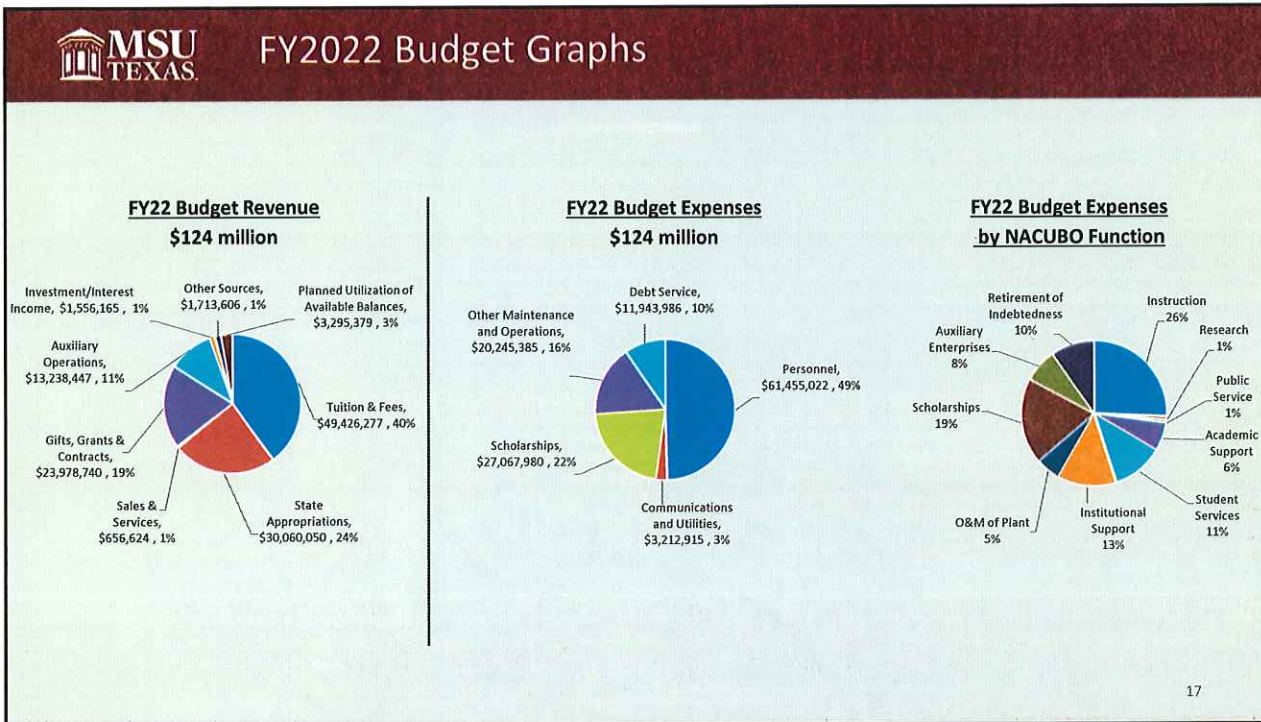
