# Online Prevention Education



- 90% of new TTU first year and transfer students completed the first part of the HAVEN online educational module related to sexual misconduct.
- Approximately 7,000 students.
- Includes e-sign feature for student to acknowledge receipt of the Student Handbook and other related policies.

# “Red Zone” Prevention

## *The First 6 Weeks*

- All new freshman and transfer students participate in Red Raider Orientation. Safety and wellness information was disseminated to students and parents.
- 450 students participated in extended programming at Red Raider CAMP.
- Sorority 101 and Fraternity 101 provided information to more than 2000 new members prior to the recruitment process.
- Raider Ready Freshman Seminar course educates approximately 1500 students about the college transition and featured sessions on safety and wellness.

# Bystander Intervention

- Bystander intervention is a required educational component that teaches students skills related to helping behaviors, increasing motivations to help others, and developing skills and confidence in helping situations.
- Bystander intervention can be an effective way to prevent sexual assault and domestic violence. Examples of efforts on campus are StepUp! Bystander Intervention and the One Love Foundation Escalation Workshops.

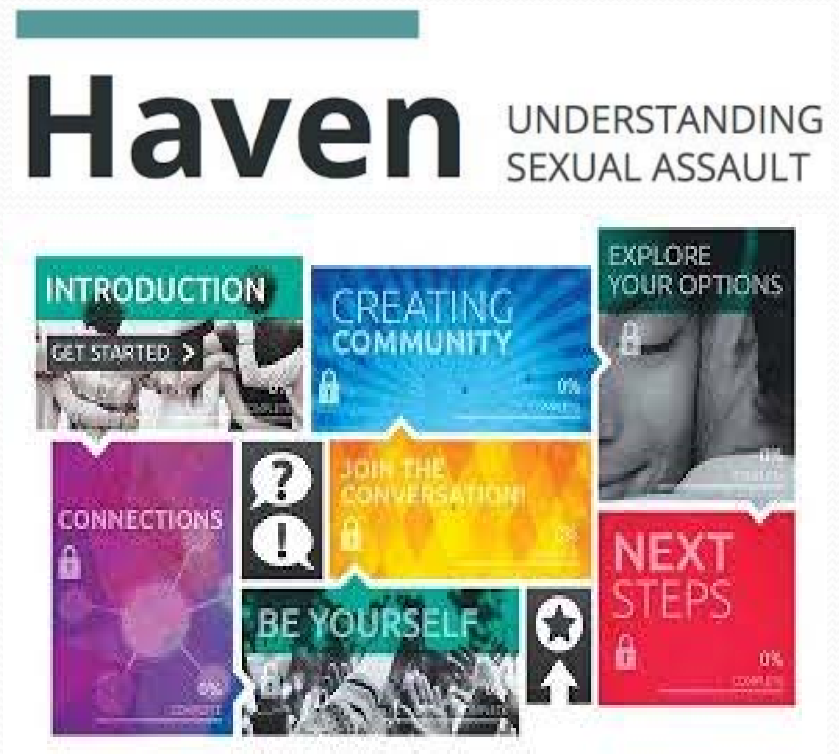
- Helping education students about consent is a critical component of prevention of sexual assault.

# Prevention Education

- 76% of incoming students (new students, transfer students, and graduate students) have completed Part I of the Haven online educational module related to sexual misconduct.
- In the future before New Student Orientation, parents will be directed to a website which includes information about Haven and resources for parents regarding talking to students about sexual misconduct and what to do if their student has experienced sexual assault, sexual harassment, relationship violence, or stalking.





# Orientation Programs

- Over 1200 new students received information on access to resources, student conduct and reporting.
- 78 transfer students received the same information and presentation during Transfer Student Orientation.
- Approximately 130 international students participated in a similar International Student Orientation.
- *Greek 101* – Greek Life Membership Training offers an opportunity for Greek Members to learn more about Title IX and the resources available through the Title IX office in a Greek Orientation Event.



# Girls Night Out



- Over 1300 ladies from ASU including students, staff, and faculty attended Girls Night Out where speakers Pat Smith and Dr. Matt Walton discussed healthy relationships and sexual assault. In addition ladies also received a R.A.D. (Rape Aggression Defense) training. Students were informed about the University Counseling Center and had access to counselors during the event.
- ASU is currently partnering with student organizations and the Laura W. Bush Foundation to provide a similar Guys Night Out event next year.
- Next year, ASU will provide extended programming before and after the Girls Night Out/Guys Night Out events and will incorporate additional education on sexual assault, sexual harassment, relationship violence, and stalking.
